## Legal aid for family services relaxed

*Vancouver, BC* — The Legal Services Society (LSS) has relaxed restrictions that until now limited most legal representation services in family law to matters involving violence or the potential removal of children from the province.

Effective June 15, the society will provide representation to financially eligible people for several issues that previously required approval from the Vancouver Regional Centre under the society's exception review process.

The issues involve kidnapping of the client's child by the person who has access but not custody; maintenance enforcement committal proceedings where the respondent faces imprisonment; and serious denial of access to children. In addition, the society will provide representation when clients cannot represent themselves because of a mental disability and the matter must be resolved to avoid further harm.

"We are making these changes because recently, when we looked at the exception review process, we found we have been approving legal representation for most clients who face these issues," said Executive Director Mark Benton. "Now local offices will usually determine eligibility for these issues, so an added benefit is that the application process for clients will be faster," he added.

Earlier this year, the society initiated a review of all its family law services.

"We're interviewing family law clients to evaluate our representation, advice, self-help, and information services, and find out how people deal with issues over time, including what happens when problems re-emerge," said Benton. "The findings will help us identify where to direct our resources and determine which services should be expanded and how."

The review involves interviews with a representative sample of clients who use the society's LawLINK, LIOW, LawLINE, Supreme Court and Provincial Court Family Duty Counsel, Family Advice Lawyer (at family justice counsellor offices), and referral (limited scope, emergency, and extended referral) services.

"We anticipate further family improvements once we've received and assessed the final results of the review," said Benton.
